OFFICE ORDER

In suppression of all previous orders in this regard, under section 17(1) Cr.PC, the following Civil Judges/Judicial Magistrates, District Charsadda, in the public interest, shall perform duties as MOD at evening after court hours, on Sundays and other public holidays except the month of August, as per the following schedule:

| 4. | Civil Judge/JM-V, Charsadda | 8 th to 10 th of each month |
| 5. | Civil Judge/JM-VI, Charsadda | 11th to 13th of each month |
| 6. | Civil Judge/JM-VII, Charsadda | 14 th to 16 th of each month |
| 7. | Civil Judge/JM-I, Tangi | 17 th to 19 th of each month |
| 8. | Civil Judge/JM-III, Tangi | 20th to 22nd of each month |
| 9. | Civil Judge/JM-I, Shabqadar | 23 rd to 25 th of each month |
| 10. | Civil Judge/JM-II, Shabqadar | 26th to 28th of each month |
| 11. | Civil Judge/JM-III, Shabqadar | 29th till end of each month |

Note:

- (1) The CJ/JMs Tangi and Shabqadar along with their staff, shall perform their MOD at District Headquarter, Charsadda in the court of learned CJ/JM-IV, Charsadda.
- (2) The MOD shall abstain from casual leave unless allowed, under unavoidable circumstances.
- (3) In case MOD is on leave, the next Judicial Officer in above sequence shall perform MOD.
